

iRefund Carnavalito Langley 2026

Spin & Win – Official Rules & Regulations

NO PURCHASE NECESSARY

1. Promotion Period

The iRefund Carnavalito Langley 2026 Spin & Win promotion (the “Spin & Win”) will take place on **September 6, 2026**, at the iRefund booth at Carnavalito Langley 2026.

Participation will be available during the operating hours of the iRefund booth, while prize supplies are available.

2. Eligibility

The Spin & Win is available to eligible participants who complete the official iRefund Carnavalito registration process at the iRefund booth.

The following individuals are **not eligible to receive Spin & Win prizes**:

- employees, representatives and contractors of iRefund;
- any individual directly involved in the organization, administration or operation of the Spin & Win promotion; and
- immediate family members or household members of any of the individuals listed above.

For purposes of these Rules, “immediate family” includes a spouse or common-law partner, parent, child, sibling, and the spouse or common-law partner of any such person, whether or not they reside in the same household.

No purchase is necessary to participate or win.

3. How to Participate

To participate in the Spin & Win, an eligible participant must complete the official iRefund Carnavallito registration process at the iRefund booth.

Each eligible registered participant is entitled to **one (1) Spin & Win participation only** during the event.

A child or other person may physically spin the wheel on behalf of a registered participant; however, the prize awarded belongs exclusively to the registered participant associated with that spin.

Duplicate participation may be disqualified.

4. Spin & Win Prizes

The Spin & Win wheel may award one of the following prizes:

- **\$50 towards an eligible personal tax return**
- **\$75 towards an eligible personal tax return**
- **\$100 towards an eligible personal tax return**
- **VIP Free Tax Review**
- **iRefund Mug**
- **iRefund Pen**

The prize indicated by the Spin & Win wheel at the completion of the participant's spin will be the prize awarded, subject to verification and these Official Rules & Regulations.

Prizes have no cash value except for the stated promotional value applicable toward eligible iRefund services.

5. Prize Registration and Confirmation

An iRefund representative will record the Spin & Win prize awarded in the participant's registration record at the time of participation.

The prize recorded by the iRefund representative in the participant's registration record will constitute **iRefund's official record of the prize awarded**.

Following completion of the registration and Spin & Win process, the participant will receive an email confirming the prize awarded and providing applicable redemption information.

The prize is associated with the registered participant and the contact information provided during registration.

A forwarded email, screenshot, copied message or other reproduction does not independently establish entitlement to a prize.

iRefund may verify the participant's registration information and official prize record before applying a discount or providing a service prize.

6. \$50, \$75 and \$100 Tax Return Discounts

The **\$50, \$75 and \$100 Spin & Win prizes** may be applied toward an eligible personal income tax return preparation service provided by iRefund to the registered participant.

The discounts may be redeemed **only between January 15, 2027 and February 28, 2027**.

To redeem the prize, the registered participant must complete and submit the applicable **Tax Organizer through the iRefund website during this redemption period**.

Tax Organizers submitted before January 15, 2027 will not constitute redemption of the Spin & Win prize.

The applicable Tax Organizer must be successfully submitted **no later than February 28, 2027**.

Submission of the Tax Organizer during the redemption period preserves eligibility for the applicable discount even if preparation or completion of the tax return occurs after February 28, 2027.

If the value of the prize exceeds the cost of the eligible service, the prize may be applied up to the full cost of that service. Any remaining balance has no cash value and will not be refunded, credited, carried forward or transferred to another person or service.

Failure to submit the applicable Tax Organizer during the redemption period will result in expiration of the prize.

An expired discount has no cash or credit value.

7. VIP Free Tax Review

The **VIP Free Tax Review** must be booked no later than **December 31, 2026**.

The appointment must take place **no later than January 15, 2027** and is subject to appointment availability.

Participants are encouraged to book early to secure their preferred date and time.

If the appointment is not booked by December 31, 2026, or the required appointment does not take place by January 15, 2027, the prize will expire and have no cash or credit value.

The VIP Free Tax Review does not include tax return preparation, bookkeeping, filing, representation before a tax authority or any other professional service unless specifically agreed to by iRefund.

8. iRefund Mug and iRefund Pen

The **iRefund Mug** and **iRefund Pen** are physical prizes and must be collected at the iRefund booth at the time they are awarded.

If a participant does not collect the applicable physical prize at the time it is awarded, the prize will be considered forfeited.

Physical prizes have no cash or credit value and cannot be exchanged, transferred, carried forward, replaced or substituted for another prize.

9. Prize Conditions

Spin & Win prizes are:

- personal to the registered participant;
- valid for one-time use only, where applicable;
- non-transferable;
- not redeemable for cash;
- not available for resale; and
- not combinable with other iRefund discounts, credits or promotional offers unless expressly authorized by iRefund.

No unused portion of a prize will be refunded, credited, carried forward or transferred.

Professional services remain subject to iRefund's normal engagement, onboarding, documentation and client-acceptance requirements.

Winning a Spin & Win prize does not, by itself, establish a professional-client relationship with iRefund.

10. Spin & Win and Grand Prize Draw

The **Spin & Win promotion** and the **iRefund Carnavalito Langley 2026 Grand Prize Draw** are separate promotions.

The prize awarded through the Spin & Win does not determine, increase, decrease or otherwise affect a participant's chances of winning a Grand Prize.

Participation in the Grand Prize Draw is subject to separate **Grand Prize Draw Official Rules & Regulations**, including its applicable eligibility and entry requirements.

11. Disqualification

iRefund reserves the right to disqualify a participant or cancel a prize in cases involving:

- duplicate participation;
 - false or misleading registration information;
 - attempted manipulation of the Spin & Win wheel or promotion;
 - attempted transfer or resale of a prize;
 - fraud; or
 - any material violation of these Official Rules & Regulations.

12. Prize Availability and Substitution

Physical prizes are subject to availability during the event.

If a physical prize becomes unavailable for reasons beyond iRefund's reasonable control, iRefund may substitute another prize or promotional benefit of equal or greater value.

If a service prize becomes unavailable for reasons beyond iRefund's reasonable control, iRefund may substitute a service or promotional credit of equal or greater value.

No cash substitution will be provided.

13. Changes, Suspension or Cancellation

If circumstances beyond iRefund's reasonable control interfere with the administration, security, fairness or proper operation of the Spin & Win promotion, iRefund reserves the right, subject to applicable law, to modify, suspend or cancel the promotion.

14. Privacy

Personal information collected in connection with the Spin & Win will be handled in accordance with iRefund's Privacy Policy and applicable privacy requirements.

Information provided during registration may be used to administer the Spin & Win, record and verify prizes, contact participants and fulfill or redeem prizes.

15. General

By participating in the Spin & Win, participants agree to comply with these Official Rules & Regulations.

iRefund's registration records will be used to determine the identity of the registered participant and the prize awarded.

A screenshot, copied or forwarded email, photograph or other reproduction does not independently establish entitlement to a prize.

The Spin & Win promotion is subject to applicable federal and provincial laws.
